#### PUPIL ABSENCE

Within St Brigid's Primary good attendance is encouraged at all times and children rewarded accordingly. Parents are asked to advise if their son or daughter is going to be absent. This should be done as early as possible on the first day of absence. If the young person is going to be absent for some time, it would be helpful to know at the earliest opportunity.

The school uses daily text messaging to inform parents and carers of absence if no contact is made. All unexplained absence is investigated by the school and appropriate action taken. All calls must be made to the Pupil Absence Reporting Line on 0141 287 0039.

The line is open between 08.00-15.30 Monday to Friday. Alternatively you can use the online form on the Glasgow City Council website: https://www.glasgow.gov.uk/index.aspx?articleid=18832

Medical or dental appointments: Parents and carers should call the Pupil Absence Reporting Line to report absences for medical or dental appointments. The school requires a letter or appointment card as evidence of the appointment to ensure permission is given to be absent from class.

Please phone the school directly to report the following absences: To make sure you receive the right support parents and carers should still contact the school directly to report absences of a sensitive or personal nature, such as: bereavement, serious illness (e.g. an absence which is going to last more than one week), injury (e.g. broken limb), contagious diseases or illness.

The pupil absence service is provided by a dedicated team of experienced Education support staff. The in-formation you provide to the team is updated in the school's system when you call, so that we are immediately aware of all absence information.



#### **Appointments during school hours**

If your child has an unavoidable appointment, please give them a letter for their class teacher and then collect them from the school office at the specified time.

#### **MEDICAL & HEALTHCARE**

The school nurse visits at various times during the year for routine health checks, vaccinations and medical examinations. Parents are kept informed by letter.

If a child becomes ill during the course of the school day, he/she may require to be sent home. Please ensure that you keep the school informed of <u>all</u> contact details.

Parents should inform the school of any medical requirements relating to their child. If a child requires medication during the school day, parents must complete the appropriate medical form. This is available on request from the school office.

#### **EMERGENCIES**

We make every effort to maintain a full educational service, but on some occasions circumstances arise which lead to disruption. Schools may be affected by, for example, severe weather, temporary interruption of transport, power failures or difficulties of fuel supply.

In such cases, we shall do all we can to let you know about the details of our closure or re-opening by using letters, texts, Twitter and the local media etc.

## SCHOOL UNIFORM

Our school uniform has been simplified to ensure affordability and has been agreed in consultation with pupils and parents.

School ties and badges are available for purchase at the school office.





#### **PE Kit**

It is important that pupils come prepared to learn and for PE this requires appropriate clothing. All jewellery should be removed. Pupils who are not participating in PE must have a note or a medical certificate. Pupils who are unable to participate in practical PE should still bring their kit to allow them to assist in the lesson by refereeing, keeping scores or assisting with the distribution of equipment. This ensures that they are still able to take part in some way in the work of the class and do not miss out on the knowledge and understanding of the course.

Our classrooms are carpeted and we ask that all children wear plain black gym shoes in school.

There are forms of dress that are unacceptable in school, such as items of clothing which:

- Potentially encourage factions (such as football colours) •
- Could cause offence (such as anti-religious symbolism or political slogans) •
- Could cause health and safety difficulties (such as loose fitting clothing, jewellery) •
- Could cause damage to flooring •
- Carry advertising particularly for alcohol or tobacco •
- Could be used to inflict damage on other pupils

#### **CLOTHING & FOOTWEAR GRANTS**

Parents/Carers receiving Income Support, Job seekers Allowance (Income Based), Working Tax Credit (with a total annual income of less than £15,860\*), Housing Benefit, Council Tax Benefit of Universal Credit (where the total income is less than £7320. #### SCHOOL MEALS

Our school provides a lunch service which offers a variety of meals and snacks. Medical diets for children can be provided. Children who prefer to bring packed lunches will be accommodated in a suitable area.

All children in P1-P4 are entitled to a free school meal.

If you plan to send your child/children to breakfast club, you should inform the staff of any medical dietary requirements.

Children and young people of parents/carers receiving Income Support, income based Job Seekers Allowance, Working Tax Credit (where income is less than £7920\*), Child Tax Credit only (where income is less that £16,500\*), Universal Credit (where income is less than £7,320) and income-related Employment and Support Allowance are entitled to a free midday meal. #### TRANSPORT

The education authority has a policy of providing free transport to all pupils who live outwith a certain radius from their local school by the recognised shortest walking route. This policy is more generous than the law requires. This means that the provision of transport could be reviewed at any time. ### TRANSFER FROM PRIMARY TO SECONDARY SCHOOL

Children and young people normally transfer between the ages of  $11\frac{1}{2}$  and  $12\frac{1}{2}$ , so that they will have the opportunity to complete at least 4 years of secondary education. Parents and carers will be informed of the school arrangements no later than December of Primary 7.

We work closely with Holyrood Secondary School staff to prepare our Primary 7 pupils for their transfer to secondary school.

### COMMUNICATION WITH PARENTS

At St Brigid's we use a variety of ways to keep in touch.

Open Door Policy - the senior leadership team are available for all parents and carers at any time provided they are not teaching or in another meeting. Please either pop in to the school office or phone for an appointment.

*Newsletters* – will be sent out on a regular basis to keep parents informed about the work of the school.

*Letters* – further information which requires a response may be sent out in letter form.

School website/Twitter – will contain a great deal of information about the school. It is a good idea to check this regularly.

Text messaging /email - You may also receive text reminders or emails about events/ school closures etc.

Meetings - Parents and carers are welcome in the school to discuss any aspect of their child's development and progress. To avoid disappointment, it is advisable to make an appointment. There are various opportunities throughout the year when parents can discuss their child's progress with the class teacher and view the child's work.

Parents and carers are welcome at other events throughout the school year e.g. shared learning, information evenings, class performances, religious and other assemblies. The school newsletter and website will keep you informed.

#### EMERGENCY CONTACT INFORMATION

At the start of each school session, parents will be issued with the annual data check form. Please ensure that this is completed and returned to the school. It is also important that you let us know if there are changes to your telephone number(s) or to those of your emergency contacts throughout the year.



### DATA PROTECTION – USE OF INFORMATION ABOUT CHILDREN AND PARENTS/ CARERS

We collect information about children attending school (and also about parents/carers, emergency contacts etc. provided in the annual data check) to allow us to carry out the Councils' functions as the education authority for the City of Glasgow. This may sometimes involve releasing personal information to other issues or criminal investigations, and it may also be used for research purposes (see the link below for more details regarding this)

Information held by the school is, in legal terms, processed by Glasgow City Council. The Council is registered as a data controller under the Data Protection Act 2018 and all personal data is treated as confidential and used only in accordance with the Data Protection Act, the General Data Protection Regulations, and the information use and Privacy Policy approved by the City Council. ## **CURRICULUM FOR EXCELLENCE 3-18**

Curriculum for Excellence has been introduced to raise standards of learning and teaching for all 3 to 18 year olds. It aims to help prepare children and young people with the knowledge and skills they need in a fast changing world. As part of Curriculum for Excellence, all children from pre-school to the end of Secondary 3 will receive a rounded education known as a Broad General Education (BGE). Curriculum for Excellence is all about bringing real life into the classroom and taking lessons beyond it.

Through the experiences we provide at St Brigid's Primary we want our children to become Successful Learners, Confident Individuals, Responsible Citizens and Effective Contributors. We are committed to providing children with a broad general education and focus on eight curriculum areas.

Expressive arts: The inspiration and power of the arts play a vital role in enabling our children and young people to enhance their creative talent and develop their artistic skills.

Health and wellbeing: Learning in health and wellbeing ensures that children and young people develop the knowledge, understanding and skills which they need now and in the future to help them with their physical, emotional and social wellbeing.

Science: Science and its practical application in healthcare and industry is central to our economic future, for our health and wellbeing as individuals and as a society.



Social Studies: Through social studies, children and young people develop their understanding of the world by learning about other people and places both past and present, societies, their beliefs and values.



Languages: Knowing other languages and understanding other cultures is a 21st century skill set for students as they prepare to live and work in a global society. We offer French and Spanish and Gaelic tasters.

Mathematics: Mathematics equips us with the skills we need to interpret and analyse information, simplify and solve problems, assess risk and make informed decisions.

Technologies: The range of subjects in technical education has changed significantly over the last two decades and now includes computer science, craft, design, engineering and graphics.

Religious Education and Observance: Our religious education is provided in accordance with the teaching of the Roman Catholic Church which is specifically developed through This is our Faith and God's Loving Plan. Learning through religious education enables children to develop knowledge and understanding of the Catholic faith and to investigate and understand the relevance of the Catholic faith while questioning the truth and meaning of life. Religious Education aims to develop and foster values, attitudes and practices which are compatible with a positive response to the invitation to faith. It aims to inform conscience when making moral decisions, and to nurture prayer life through communal and personal prayer. We plan religious observance in consultation with Father Byrne, parish priest. Parents and carers who do not wish their child to participate in the school's RE programme should speak to the headteacher.



There will be opportunities throughout the year for parents and carers to learn more about aspects of the curriculum and to be consulted about significant changes, if appropriate.

# **ASSESSMENT & REPORTING**

All children are assessed both formally and informally throughout the year. This allows children and their teachers to identify their strengths and areas for improvement. A variety of assessment methods are used to enable staff to pass on information to parents about the progress of their child. Children at P1, P4 and P7 stages will also undertake the Scottish National Standardised Assessment for their stage. Assessment records are kept by the class teacher and form the basis of discussion at Parents' Evenings in October and March. An annual report is sent to parents towards the end of each school year.

If you have any concerns about your child's progress do not hesitate to contact the school.



#### **PUPIL PROFILES**

Every child leaving primary school in Scotland has their key achievements in school, at home and in the community documented within a P7 profile. The content of the profile is decided by the young person. The profile is a positive record of their achievements and emphasis their strengths. The profile provides a valuable way for learners to share valuable information about their achievements with their parents and teachers in secondary school.

# SCHOOL IMPROVEMENT

On an annual basis, you will receive a copy of our Standards and Quality Report. Copies from previous years are available on the school website. The Standards and Quality Report highlights progress in key curricular areas such as literacy, numeracy and health & wellbeing. Our priorities for improvement are detailed in our School Improvement Plan which is discussed with our Parent Council. Any parent or carer seeking a copy of the plan can contact the school office.

# **SUPPORT FOR PUPILS**

The school has a duty to ensure that all pupils have equal access to the curriculum, with appropriate support for their needs, if required. This applies to the content of lessons, teaching strategies and minor adaptations to the school environment. There is a wide range of factors which may act as a barrier to learning. We are committed to working closely with parents and carers to ensure that they are fully involved in any decisions about support for their children's needs.

## **PROMOTING POSITIVE BEHAVIOUR**

Children's rights as outlined in the UNCRC (United Nations Convention on the Rights of the Child) are fundamental to a good school ethos. Adults in our school will work with children to ensure they are aware of their rights and fully respect the rights of others. Therefore, the approach within St Brigid's Primary is to build a positive ethos that demonstrates care and respect for all. Positive behaviour is recognised and celebrated through Golden Time, awards at assemblies and certificates sent home to parents etc.

The highest standards of behaviour are expected of pupils at all times. Where this is not the case, a variety of sanctions are used. Parents are asked to co-operate with the school in encouraging a sense of responsibility and good behaviour in their children.

## **GETTING IT RIGHT FOR EVERY CHILD (GIRFEC)**

GIRFEC stands for 'Getting It Right For Every Child'. Part of The Children and Young Person Act (Scotland) 2014, it is the Scottish Government-led approach to making sure that our children and young people and their parents or carers – can get all the help and support they need from birth right through to age 18 (or beyond if still in school).

The vast majority of Scotland's children and young people get the love and support they need from within their families and their wider, local communities. But even the most loving and caring families can sometimes need extra support. The GIRFEC approach aims to make it as easy as possible for any child or young person (and their parents) to get that help or support if they need it.

To provide that support when needed, every child in Scotland has a named individual, the Named Person, as a single point of contact. This Named Person has a responsibility to provide help and support when asked and can draw together other services if needed, co-ordinating help for the child or parents. Please do not hesitate to contact your child's Named Person at any time.

The Named Person in St Brigid's Primary School is Mr Paul Cassidy the school's Additional Support Needs Co-ordinator.

### **PLACE2BE**

We are fortunate to have **Place2Be** in school as an additional support for children. **Place2Be** provides a one to one counselling service. This service is for children who have been referred by school staff, parents or carers, or the children themselves - though no work would go ahead without parental consent. When children need some extra support and it is having an effect at home or school or both, they can spend time with a counsellor once a week in a specially designed playroom in the school. Parents are also supported during this time. Place2Talk is a drop in service for all the children in the school (unless parents say that they do not want their children to take part). Children can make an appointment to talk about things that are worrying them, or to share a piece of good news.

# **CHILDREN'S VOICE**

We have a number of school councils to ensure that all pupils have a voice in the life of the school and in improving the work of the school.

The Pupil Council is the spokespeople for all the children in their class. They are the children's first port of call if they feel that anything in the school is not working as well as it could be. They also help to advertise and organise events in the school.

The Health Committee endeavour to encourage fitness and healthy eating. They also help to organise fundraising events and raising awareness of any events or initiatives the school is working on.

The Eco Committee are responsible for litter picking and improving the school grounds. They raise awareness for saving energy and recycling.
